

## HISTORY

- 1978** Native of Laurier - Station in the region of Quebec, Jacques Auger, very young, wanted to follow in the footsteps of his father, trucker-craftsman and passionate about mechanics. At 19, he buys his first truck to transport asphalt and gravel.
- 1986** Foundation of Transport Jacques Auger Inc. in Laurier-Station. Obtaining in fall, an Ultramar contract for the transport of heating oil.
- Transport Jacques Auger Inc. now has three clients: Ultramar, Ciment Québec and Transport Saguelac.
- 1992** This year marks a turning point for the company and represents the biggest challenge to date for Jacques Auger. The oil companies opt for subcontracting in the transportation of their products. At this time, Transport Jacques Auger has 12 trucks. The location at Laurier-Station is too small and no longer responds to new business challenges. Jacques Auger therefore bought land in St-David (Levis), very close to the Ultramar refinery, to build a new garage there which will also house administrative staff. A major investment for the time of more than half a million dollars.
- 1993** Obtaining a first three-year transport contract with Esso which, moreover, has been constantly renewed until today.
- 1994** The company decides to devote all its activities exclusively to the transport of petroleum products. It continues to grow with the acquisition of carriers specialized in petroleum products.

- 1996** Acquisition of Pétrole Hamel equipment in Montreal and birth of the Montreal terminal.
- 1998** Acquisition of Queensway Tanks Lines Inc., specializing in bitumen and petroleum products transportation. This will serves the Ottawa and Hamilton areas.
- 2002** Transport Jacques Auger acquires all the assets relating to the petroleum products transportation from its competitor Lévy Transport Itée, with its 2 terminals in Levis and Montreal.
- 2004** In January, the company acquired the assets relating to the petroleum products transportation from the company Transforce inc., Namely Transport Forestville and Retex Transport.
- 2009** In May, the company acquired Pétroles Bilodeau, which serves several customers in Bas-St-Laurent and Gaspésie from Rimouski.
- 2010** Queensway Transport Inc. foundation. The goal is to expand specialized tanker transportation services. Today we have all the necessary expertise in hazardous materials transportation, distribution of chemicals and liquid bulk by tank.
- 2019** First liquefied natural gas (LNG) transport contract obtained in January.
- Acquisition in October of assets relating to the transportation of petroleum products from GMRioux in New Brunswick, namely Grand Falls Energie inc.
